- 1. The Directorate of Municipal Administration (DMA) intends to improve quality of accounting in the ULBs (Urban Local Bodies), through mentoring and validating the accounting process along with continuous internal audit.
- 2. The Services sought:

Brief description: The DMA, proposes to establish Accounting Monitoring and Validation Teams, consisting of qualified and experienced accounts personnel, which can guide and handhold in the accounting process, apart from identifying flaws and errors, and assist in rectifying them.

3. The need of Consultants -

i. Accounting Consultant - 4 Nos (one per 25 ULBs apprx)

• Minimum requirement:

Any degree, preferably higher/additional qualification in accounting and auditing with computer knowledge. At least 10 years' experience in the Government sector in accounts and audit out of which experience in dealing with ULB is preferred.

- Job Description:
 - Should identify lacunas, laxities and problem areas in accounting at ULBs, and should be able to guide both accounts and non-accounts staff, in right accounting practices.
 - Review of Collection accounting (inflow) and payments accounting (outflow), review of daily, monthly and yearly procedures, preparation of annual performance report.
 - Monitoring of accounting system compliances and function as internal auditors for auditing of ULBs aimed at elimination of accounting errors.
 - Monitoring implementation of Fund Based Accounting System.

They will be given a task schedule every month, and should submit report after every visit to a ULB.

- Duration of contract: 6 months from the date of contract. (likely to be extended for another 12 months on satisfactory service)
